Invitation for Bids for CONSTRUCTION WORKS OF PRASASAKIYA BHAWAN

1. The Government of Nepal [GoN] *has allocated fund* towards the cost of **CONSTRUCTION WORKS OF PRASASAKIYA BHAWAN** under the Contract No. **CRM/W/NCB/ARG/19/076/77**. Bidding is open to all eligible as per Section V of bidding document.
2. **Chhatradev Rural Municipality, Office of Rural Municipal Executive, Chhatradev-5 Arghakhanchi** invites electronic bids from eligible bidders for the **CONSTRUCTION WORKS OF PRASASAKIYA BHAWAN** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best **3** years within the last **10** years: **Rs 4,75,00,000.00**
 - Minimum Work experience of similar size and nature: **1 (One)** number of project and value of project being **Rs 5,05,00,000.00**
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

6. Pre-bid meeting shall be held at **Chhatradev Rural Municipality, Office of Rural Municipal Executives** at 2077/04/08, 13:00 Hrs
7. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egg on or before **12:00 hrs on 2077/04/23**. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 Hrs on 2077/04/23** at the office of **Chhatradev Rural Municipality, Office Of Rural Municipal Executive, Chhatradev-5, Arghakhanchi**. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **Rs 19,97,000.00**, which shall be valid for 30 days beyond the validity period of the bid i.e. 2077/07/20.
9. If the last date of submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
