- 1. **The Government of Nepal (GoN)** has allocated TB-SWAP funds to **Chhatradev Rural Municipality** for **Trail Bridge Program** and the Rural Municipality intends to apply the funds to cover eligible payments under the Contract for supply of fabricated steel parts for Trail Bridges. Bid is open to all eligible Nepalese Bidders.
- 2. The **Chhatradev Rural Municipality** invites sealed quotation from registered fabricators for supply of fabricated steel parts for following Trail Bridges. Detailed Evaluation and Qualification Criteria are provided in Section III of the Bid Documents.
- 3. The Bidders/Fabricators with experience of successfully completing fabrication and supply of steel parts for minimum five trail bridges within last five years. New fabricators may apply in joint venture with an eligible firm having the required experience. Fabricators who are not enlisted by DoLI may also apply. However, bids of such fabricators shall be considered responsive only in case fabricators fulfill the requirements.

- 5. Sealed Quotation Forms may be purchased by eligible Bidders on or before **2076/08/12** on the submission of a written application and upon payment of a non refundable fee of **Rs. 1,000.00**
- 6. Sealed Quotations must be submitted to the above office on or before *12.00 hours* on 2076/08/13. Quotation received after this deadline shall not be accepted.
- Sealed Quotation shall be opened in the presence of Bidders' representatives who choose to attend at 13:00 hours, 2076/08/13at The Chhatradev Rural Municipality, Office of the Rural Municipal Executive, Chhatragunj, Arghakhanchi
- 8. Quotations must be valid for a period of *45 days* after opening of Sealed quotations and must be accompanied by Cash Security or Bank Guarantee, amounting as mentioned below which shall be *valid for 75 days* after opening of the Sealed Quotations.
- 9 If bidder wishes to submit the Cash Security, the cash should be deposited in **Deposit Account No** 0550000841in the name of The Chhatradev Rural Municipality, Office of the Rural Municipal Executive, Chhatragunj, Arghakhanchi at Nepal Banagaladesh Bank, Chhatragunj Branch, Arghakhanchi and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
- 10. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day.
