4. Pre-bid meeting shall be held at Chhatradev Rural Municipality, Office of Rural Municipality Executives at 13:00 Hrs on 2078/05/14 (30-08-2021).
5. Electronic bids must be submitted through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12:00 hrs on 2078/05/24 (09-09-2021). Bids received after this deadline will be rejected.

Bids shall be opened in presence of Bidders' representatives who choose to attend on 13:00 Hrs on 2078/05/24 (09-09-2021) at the office of Chhatradev Rural Municipality, Office Of Rural Municipal Executive, Chhatragunj, Arghakhanchi.]. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, amounting to a minimum of NRs. 87,000 which shall be valid for minimum 30 days beyond the bid validity period.
