- 5. Electronic bids must be submitted through PPMO website <a href="www.bolpatra.gov.np/egp">www.bolpatra.gov.np/egp</a> on or before 12:00 Hours on 2079/10/19 (02 February, 2023). Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 Hours on 2079/10/19 (02 February, 2023) at the office of Chhatradev Rural Municipality, Office of Rural Municipal Executive. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of as shown in Table, which shall be valid for 30 days beyond the validity period of the bid
